Project Description:

The selected consultant will be tasked with developing a Comprehensive Nutrient Management Plan (CNMP) for a 120-cow beef operation in Port Matilda, PA. The operation spans the home farm and 13 additional tenant farms. During the growing season, the herd is spread among pastures across 7 properties (home farm and 6 tenant farms). A detailed breakdown of pasture usage during the growing season is available in the table on Page 4. The remaining tenant farms are used for crop production and manure application. In the winter, all cows are housed at the home farm, where manure is stored on a concrete pad. This manure is later spread across the home and tenant farm crop fields. A detailed list of each property, including specific operational information, is provided on Page 4.

In addition to beef cows, the Burke family raises other livestock at the home farm throughout the year, including:

- 50-100 free-range laying hens
- Approximately 800 meat chickens raise 200 chickens in moveable chicken tractors four times per year
- 40-50 meat goats, which are kept year-round. The goats are harvested twice a year, with a cycle of 6-12 months to reach maturity.
- Approximately 120 turkeys, raised seasonally around Thanksgiving
- 10-20 pigs, with 10 breeders kept year-round. The pigs are harvested twice annually.

The Burke's take pride in being local farmers committed to enhancing their operation. They currently practice rotational grazing, crop rotation, and produce feed for all their animals on the farm.

Plans must meet Natural Resource Conservation Service (NRCS) Standards for CNMP development. Please refer to the Field Office Technical Guide for the most recent requirements. The CNMP must include three key components: 1) a Conservation Plan for all crop acres, 2) a Nutrient Management Plan addressing all nutrient sources applied to cropland and pasture, and 3) an Engineer's Inventory and Evaluation (I&E), including cost estimate, for the home farm only.

Services to be provided include, but are not limited to:

- **Collaboration and Coordination:** Work closely with landowner to conduct thorough site visits, evaluating current management practices, land use, and existing infrastructure.
- Data Collection: Work with the landowner(s) to gather essential information, including livestock numbers, feed and forage practices, manure production, and current nutrient management strategies.
- **Environmental Assessment:** Identify and assess critical areas with potential environmental impacts, such as waterbodies, drainage patterns, and sensitive habitats.
- **Nutrient Recommendations:** Develop field-specific nutrient recommendations ground in crop needs, soil tests, and manure analysis to optimize nutrient application and soil health.
- Best Management Practices (BMPs): Identify and recommend BMPs aimed at protecting
 water quality, controlling erosion, and mitigating environmental impacts. Recommended
 BMPs, including stream buffers, shall be designed to meet NRCS specifications and to
 ensure that producer meets eligibility requirements for programs such as EQIP, RCPP, etc. In

addition, the contractor will consult with Chesapeake Conservancy and other partners to ensure that stream buffer design meets the minimum grant specifications.

- **Regulatory Compliance:** Ensure that the CNMP adheres to all applicable local, state, and federal regulations, particularly those established by NRCS.
- **Comprehensive Documentation:** Compile the CNMP into a detailed report that includes maps, calculations, and all necessary supporting documentation.
- **Final Submission:** Submit the completed CNMP to NRCS Centre County field office for review and approval.

RFP TERMS AND CONDITIONS

Selected contractors will be working with Chesapeake Conservancy, Clearwater Conservancy, and NRCS field office on the implementation of this project.

PLAN DEVELOPMENT TIMELINE:

CNMP shall be completed as soon as possible. Contractors shall include with their response when they can begin working on the CNMP and their projected completion date. Preference may be given to contractors who can complete the CNMP by Spring 2025.

If the contracted services are not completed within the designated time period (as specified in the resulting contract from this RFP, the contract can be extended if agreed to in writing by Chesapeake Conservancy and the contractor.

COMMUNICATION AND CRITICAL TASKS:

Communication between the contractor, Clearwater Conservancy and Chesapeake Conservancy is crucial to a successful project. Each contractor shall notify the landowner, Clearwater Conservancy and Chesapeake Conservancy when they will be onsite.

Contractor shall verify with NRCS, producer, and partners that the CNMP and associated BMPs meet NRCS and partner specifications as well as meet the needs of the producer.

PAYMENT INFORMATION:

This project is funded by a Pennsylvania Department of Environmental Protection (DEP) Growing Greener Watershed Renaissance Initiative Grant.

Invoices will be accepted when all components of the CNMP have been completed or following a predetermined payment schedule. Payment will be issued on a Net 30 schedule upon submission of an approved invoice and a completed Application for Payment form.

<u>ENHANCED MINIMUM WAGE PROVISIONS:</u> Enhanced minimum wage provisions apply to contractors and subcontractors who complete any services and tasks described in the Project Description. Enhanced minimum wage applies when a contractor's employee(s) spends at least twenty percent of their time performing work on the project in a given work week.

- Contractors shall follow and ensure that all subcontractors follow the required enhanced minimum wage provisions outlined below per Pennsylvania's Department of General Services*.
- Effective July 1, 2024, the enhanced minimum wage rate is \$16.74 per hour (54.Pa.B. 1524).
- An annual cost of living adjustment is applied to the minimum wage rate each July. All services completed after July 1st must be paid at the new rate.
- Contractor and all subcontractors will be required to send timesheets/payroll documentation to Chesapeake Conservancy.

*PA Department of General Services

Enhanced Minimum Wage Provisions

a. **Enhanced Minimum Wage.** Contractor/Lessor agrees to pay no less than \$16.74 per hour to its employees for all hours worked directly performing the services called for in this Contract/Lease, and for an employee's hours performing ancillary services necessary for the performance of the contracted

- services or lease when such employee spends at least twenty percent (20%) of their time performing ancillary services in a given work week.
- b. **Adjustment**. Beginning July 1, 2023, and annually thereafter, the minimum wage shall be increased by an annual cost-of-living adjustment using the percentage change in the Consumer Price Index for All Urban Consumers (CPI-U) for Pennsylvania, New Jersey, Delaware, and Maryland. The applicable adjusted amount shall be published in the Pennsylvania Bulletin by March 1 of each year to be effective the following July 1.
- c. Exceptions. These Enhanced Minimum Wage Provisions shall not apply to employees:
 - 1. Exempt from the minimum wage under the Minimum Wage Act of 1968;
 - 2. Covered by a collective bargaining agreement;
 - 3. Required to be paid a higher wage under another state or federal law governing the services, including the Prevailing Wage Act and Davis-Bacon Act; or
 - 4. Required to be paid a higher wage under any state or local policy or ordinance.
- d. **Notice**. Contractor/Lessor shall post these Enhanced Minimum Wage Provisions for the entire period of the contract conspicuously in easily-accessible and well-lighted places customarily frequented by employees at or near where the contracted services are performed.
- e. **Records.** Contractor/Lessor must maintain and, upon request and within the time periods requested by the Commonwealth, furnish all employment and wage records necessary to document compliance with these Enhanced Minimum Wage Provisions.
- f. **Sanctions**. Failure to comply with these Enhanced Minimum Wage Provisions may result in the imposition of sanctions, which may include, but shall not be limited to, termination of the contract or lease, nonpayment, debarment or referral to the Office of General Counsel for appropriate civil or criminal referral.
- g. **Subcontractors**. Contractor/Lessor shall include the provisions of these Enhanced Minimum Wage Provisions in every subcontract so that these provisions will be binding upon each subcontractor.

EQUAL EMPLOYMENT OPPORTUNITY:

Chesapeake Conservancy is an equal opportunity employer. The successful bidder shall comply with all federal, state, and local equal employment opportunity requirements. Additional information can be found at https://www.ecfr.gov and searching 41 CFR 60-1.4(b).

SMALL BUSINESS AND SMALL DIVERSE BUSINESS:

Chesapeake Conservancy encourages the use of small and small diverse businesses when soliciting Requests for Proposals. Please note Pennsylvania Department of General Service registration is only valid for three years. Contractors are encouraged to verify that their registration is current.

Contractors and any subcontractors who register on Sam.gov and with the PA Dept of General Services and who qualify as a small and/or small diverse business should check the applicable boxes on the Contractor Response Form.

WORKER PROTECTION INVESTMENT AND CERTIFICATION FORM:

Commonwealth grants require contractors to sign the Commonwealth of Pennsylvania Worker Protection Investment and Certification Form acknowledging compliance with Executive Order 2021-06, Worker Protection and Investment (October 21, 2021). Contractors shall complete Attachment A and submit it with their RFP response.

DEBARMENT AND TAX LIABILITY:

Contractors are required to certify that they and any subcontractors are not listed on the Debarment and

Suspension List maintained by the Pennsylvania Department of General Services (https://www.dgs.internet.state.pa.us/debarmentsearch/debarment/index) and the General Services Administration's List of Parties Excluded from Federal Procurement or Nonprocurement Programs (https://www.sam.gov/search/) in accordance with Executive Orders 12549 and 12689, "Debarment and Suspension" and have no outstanding tax liabilities. Contractor will also be required to certify that they and any subcontractors are not in default of a loan or funding agreement administered by any Commonwealth agency.

INSURANCE REQUIREMENTS:

Bidders shall include a copy of their current Certificate of Insurance (COI) that reflects their existing levels of liability insurance coverage. Chesapeake Conservancy will work with the successful bidder to ensure adequate levels of insurance are in place for the project prior to finalizing a contract.

It is preferred that **all policies and coverages** (except workers compensation) include a waiver of subrogation and list "**Chesapeake Conservancy**" as additional insured.

Once Chesapeake Conservancy and the successful bidder have reached an agreement pertaining to insurance coverage, the successful bidder shall provide Chesapeake Conservancy with a current COI certified by a licensed insurance broker. The approved COI needs to be provided to Chesapeake Conservancy prior to signing a contract.

Note: Bidders do not need to add the additional insured and waiver of subrogation to their policy when responding to the RFP. Only the successful bidder will be required to name the additional insured and waiver of subrogation on their policy after the bid is awarded.  - It is the responsibility of each Contractor to ensure that the bid is received prior to the due date and time for submission of proposals. No proposal shall be considered if it was sent or received after this date and time.
- C. Bids must be firm. If a bid is submitted with conditions or exceptions or not in conformance with these terms and conditions, it shall be rejected. The bid shall also be rejected if the items offered by the contractor are not in conformance with the specifications as determined by the Issuing Office.
